Discussion on Disc Golf Course- Eagle Scout Project

Supervisor Emmendorfer introduced Scout Kyle Gibbs. Kyle is working on earning his Eagle Scout Badge. Kyle is seeking the Boards approval to build a 9-hole disc golf course starting in Barber Park and then moving toward the Township Municipal Building.

Roads and Ditches Follow-up Funding

Genesee County Road Commission is doing spot repairs on Marshall Rd from Farrand to Lake Rd, and then on Morrish Rd. from Vienna Rd to Farrand. To cover the cost of these repairs the Township needs to transfer \$19,970 from General Funds to GL line item 277-526-935.000.

A **Motion** was made by Steve Schlicht to transfer \$19,970 from the General Fund into GL line item 277-526-935.000 to pay for the 2023 spot repairs. Support was given by Gary Keeler. Roll call - Steve Schlicht (yes), Mary Quast (yes), Gary Keeler (yes), Mark Emmendorfer (yes). Motion passed.

Road Commission Chloride Program

Two Chloride applications this year will cost Montrose Township \$20,603.44. The first application is \$41,206.88, the Township is responsible for 50% and Genesee County Road Commission covers the other 50%. The second application is covered 100 % by Genesee County Road Commission. If we need a mid-summer application, it will cost the township an additional \$41,206.88.

We received 3 bids for graphics on the new Fire Trailer. Professional Graphics came in at \$2,200. Agnew Sign Company's bid was \$2,750. Media Skapes came in at \$7,072. Steve Schlicht shared that Professional Graphics will come right to the Fire Department Bay and do the work. A **Motion** was made by Mary Quast to accept the bid from Professional Graphic for \$2,200. Support for the motion was given by Steve Schlicht. Roll call – Gary Keeler (yes), Mark Emmendorfer (yes), Steve Schlicht (yes), Mary Quast (yes). Motion passed.

Generator for Fire Trailer

The Fire department has been working on the new trailer and adding lights. They are planning to store the quads, water rescue equipment, and grain rescue equipment in the new trailer. A generator is needed. A new Honda 3000IS1AN 3000W 120V Home Gas Power generator is \$2399.00. Fire Chief, George Taylor has the exact model that he used for personal use and is willing to sell it to the Township for \$1,500. This generator has approximately 20 hours on it, it has a new battery and has been serviced.

A **Motion** was made by Steve Schlicht to purchase the generator from Fire Chief, George Taylor for \$1,500. Support for the motion was given by Gary Keeler. Roll call – Mark Emmendorfer (yes), Steve Schlicht (yes), Mary Quast (yes), Gary Keeler (yes). Motion passed.

John Deere Quote for New Broom Attachment

The Building and Grounds mower is in need of a new broom. The 20-year-old broom attachment we had, the drive shaft was sheered and is beyond repair. A replacement broom from John Deere is \$5,285.

Proposal for Apex Sketch Program

This program is for the Assessing Department to make real estate cards for every parcel in Montrose Township. This program is nice for residents and Real Estate Agents to look up information regarding certain properties that interest them. Legacy Assessing can upload the parcels into the system for \$5 a parcel not to exceed \$14,000. Legacy assessing would be able to upload half of the townships parcels in 2023 and the other half in 2024. Any updates after the initial upload that Legacy has to complete will be done at no additional cost. It would cost the township \$7,000 in 2023 and again \$7,000 in 2024. The cost would be paid out of the General Fund.

A **Motion** was made by Gary Keeler to enter into a contract with Legacy Assessing for \$14,000 over the next 2 years. Funds will be paid out of General Funds. Support for the motion was given by Steve Schlicht. Roll call - Mary Quast (yes), Gary Keeler (yes), Mark Emmendorfer (yes), Steve Schlicht (yes). Motion passed.
