## <u>Cost agreement with Genesee County Road Commission for Solar Beacon Flasher at Duffield &</u> <u>Wilson Rd</u>

The cost to the township is \$1,250.00 which is one half of the 10% that the County has to pay after being awarded a federal grant that covers 90% of the installation cost. The total cost is \$25,000. It will be maintained by the Genesee County Road Commission after installation.
